Chronic molybdenum poisoning in laboratory animals has caused loss of weight, anorexia, anemia, deficient lactation, male sterility, osteoporosis and bone joint abnormalities.

Zinc fumes may cause metal fume fever. Effects include dry throat, metallic taste, chest pain, dyspnea, rales and dry cough.

Several hours later, chills may occur with lassitude, malaise, fatigue, headache, back pain, muscle cramps, blurred vision, nausea, fever, perspiration, vomiting and leukocytosis.
