SECTION 4. FIRST AID MEASURES

SECTION 6. ACCIDENTAL RELEASE MEASURES

Methods and materials for containment and cleaning up:

inert material and put the spilled material in an appropriate waste disposal container. Use clean nonsparking tools to collect absorbed material.
